## Minutes of 5<sup>th</sup> EACA meeting

Time: 17:00-18:00 January 26, 2012, and 16:00-17:30 January 27, 2012

Venue: Japan Council for Quality Health Care, Tokyo, Japan

## Summary of discussion issues:

- 1. Domestics clinical trials title translation format discussion
  - 1.1 In order to the possibility of integrating with CENTRAL in the future, translation format will accord to CENTRAL registration format for trials.
  - 1.2 Deborah Pentesco-Gilbert suggested confirming with CENTRAL to ensure required format.
  - 1.3 Kiichiro Tsutani suggested identifying abstract information including objectives, design, setting, participants, intervention, main outcome measures, main results, and conclusions. This is common format for reporting trial and easily for getting quick information for others, which was used in developing the abstracts of 345 RCTs of Kampo (Japanese traditional herbal) drugs in Japanese and in English with comments by third party abstractors in Jpa. They are available in website in Japan

(<u>http://www.jsom.or.jp/medical/ebm/index.html</u>), as well as in CENTRAL by using search term of EKAT and JSOM.

- 1.4 Inclusion criteria of eligible trials will be the same as criteria of CENTRAL to include RCT and CCT.
- 1.5 Considering substantial efforts and usefulness when combined into CENTRAL database in the future, to further identify PICO component from abstracts may be done if time and workforce are adequate.
- 1.6 For accelerating continuous search in the future, information for search strategies should be provided and keep transparent. Daniel Lo will revise a final search protocol and send to EACA colleagues for further confirmation.
- 1.7 Issue regarding to get individual permission of copyright from local publishers for displaying abstracts of retrieved trials in EACA webpage, please consult local publishers for relevant policies.
- 2. Translation of Cochrane Glossary
  - 2.1 Selected glossaries will be provided by Daniel Lo.

- 2.2 Please check textbook or publication from locally domain field to find available terminology (such as clinical epidemiology in Japanese)
- 2.3 The purpose of translating glossary is to help reviewers for searching language other than English can get related reference search terms.
- 2.4 In order to increase search sensitivity, each glossary may provide more than one local translation. It is necessary to provide some alternatives which may be applied by different specialties; however, please identify one which is most common used in local health care community.
- 2.5 There is a suggestion that translations are proved by peer review process. Please consult or get endorsement from your local professional expertise and provide related information for future acknowledgement in the EACA website.
- 2.6 Deborah Pentesco-Gilbert suggested translating Cochrane Minimised Standard for systematic review. This will facilitate local reviewers understanding Cochrane standard rather than to read through the whole handbook. Edwin Chan also echoes the idea. Further it would be helpful for those who teach systematic review in training program, and assistant reviewers to communicate with editorial group. Deborah Pentesco-Gilbert will help to confirm the available status for this document.
